PREPARATION	
New Surfaces	All surfaces must be sound, clean, suitably dry and free from anything that will interfere with
	the adhesion of the materials to be applied. Remove any site debris and sweep floor clean.
	Any oil or grease from site plant/works must be removed with an emulsifying de-greaser in
	accordance with the manufacturer's instructions. Floor areas to be coated should be acid
	etched to remove surface laitance, using a proprietary mortar cleaner diluted in accordance
	with the manufacturer's instructions. Rinse thoroughly with clean water to remove all
	residues. Allow to dry. Prime all areas to be coated with one coat of <b>Crown Contract Floor</b> <b>Paint</b> .
Previously Decorated	All surfaces must be clean, dry and free from anything that will interfere with the adhesion of
Surfaces	the materials to be applied. Remove loose and failing material by scraping or brushing with a
Surfaces	stiff bristle brush to a sound edge. Organic growth must be treated with <b>Sandtex Trade</b>
	<b>Fungicidal Solution</b> and removed. Any oil, grease, polish etc must be removed with an
	emulsifying de-greaser in accordance with the manufacturer's instructions. For surface dirt,
	wash with hot water and liquid detergent solution to remove any contaminants, frequently
	changing the water. Rinse thoroughly with clean water to remove all residues. Allow to dry.
	Feather edges of sound coatings and mechanically dry abrade any glossy surfaces to
	provide a key. Remove all dust by vacuum cleaning. Patch prime all bare areas (including

Avoid over application or pooling as the coating will take longer to dry/cure.</li> <li>Always intermix (box) packs for colour consistency. Please check for colour accuracy prior to application. Crown Paints is not liable for decorating costs caused as a result of an incorrect colour being applied.</li> <li>Note: Avoid placing heavy weights until the coating is fully cured.</li> </ul>
CLEANING	Return surplus material to container. Clean tools & equipment with a
	proprietary cleaner immediately after use.
STORAGE	Store upright and secure. Store in secure dry conditions inaccessible to children or animals. Containers should be kept closed during storage. Do not store below 5°C or above 40°C.
MAINTENANCE	Between maintenance redecoration, surfaces may be washed with a warm water and liquid
